NOW, THEREFORE, in consideration of the Agreement, the sum of US \$100 (one hundred US dollars), and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the Assignors, Assignors do hereby sell, assign, convey and transfer unto Assignee, its successors, assigns and legal representatives, their full and entire rights, title and interests in and to the Marks identified in said Schedule A and the attendant goodwill symbolized by the foregoing, the same to vest in Assignee, including, without limitation, the ownership of all causes of action for, and claims for damages by reason of, the infringement of any of the Marks by other parties, which causes of action and claims arose prior to the date of execution hereof.

Assignors hereby agree that Assignee shall have the right, at its sole cost and expense, to record this instrument of assignment with the United States Patent and Trademark Office and with any other agency, office or authority in any and all other jurisdictions and countries of the world, so as to establish Assignee as owner of record of the Marks.

Assignors further agree, at the request of Assignee and at Assignee's sole cost and expense, to (i) execute and have executed any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Assignment; and (ii) fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this instrument of assignment with the United States Patent and Trademark Office and with any other agency, office or authority in any and all other jurisdictions and countries of the world, so that Assignee's ownership of the Marks is duly made of record.


