This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of December 18, 2019, is made by and between Edgewell Personal Care Brands, LLC, a limited liability company organized under the laws of Delaware with an address at 6 Research Drive, Shelton, Connecticut 06484 ("Assignor") and Angelcare USA, LLC, a corporation organized under the laws of Delaware with an address at 2915 Ogletown Road, Newark, County of New Castle, Delaware, 19713, USA ("Assignee").

WHEREAS, Edgewell Personal Care Company, a Missouri corporation and an affiliate of Assignor ("Edgewell") and Le Holding Angelcare Inc., an affiliate of Assignee, have entered into the Asset Purchase Agreement dated as of the 18th of October, 2019 (the "Purchase Agreement"); and

WHEREAS, under the terms of the Purchase Agreement, Edgewell has agreed to cause Assignor to assign, or otherwise transfer or cause to be transferred, to Assignee (or its designee), the Marks (as such term is defined in the Purchase Agreement) listed on Schedule A attached hereto (collectively, the "Assigned Trademarks").

WHEREAS Le Holding Angelcare Inc. has designated Assignee as its designee for the purpose of this Assignment.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth below and in the Purchase Agreement, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound thereby, Assignor does hereby sell, assign and transfer to Assignee, Assignor's entire right, title and interest in, to and under the Assigned Trademarks and all goodwill of Assignor appurtenant to such Assigned Trademarks, in the United States and every foreign country where such Assigned Trademarks are owned by Assignor. This Assignment includes assignment to Assignee of the right to make applications on its own behalf for protection of the Assigned Trademarks and any trademarks issued on the Assigned Trademarks, in the United States, in countries foreign to the United States, and under any international arrangements or treaties. The Assigned Trademarks shall be held and enjoyed by Assignee, its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made, including, without limitation, the exclusive right to enforce and to claim damages for the past, present or future infringement or violation of the Assigned Trademarks.

Assignor covenants and agrees to execute such further and confirmatory assignments in recordable form as Assignee may reasonably require and prepare to vest record title of the respective Assigned Trademark in Assignee, at Assignee's request and at Assignee's sole expense.

This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original and all of which together shall be deemed to be one and the same instrument. Copies of executed counterparts transmitted by telecopy, fax, "portable document format" (.pdf), or other electronic transmission service shall be considered original executed counterparts.

Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand or limit in any way the provisions of the Purchase Agreement. In the event of any conflict, ambiguity or inconsistency between any provision of this Assignment and any provision of the Purchase Agreement, the applicable provision of the Purchase Agreement shall be deemed to be controlling.
