TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement ("Agreement") is made and entered into as of December 20, 2019 ("Effective Date") by and between Turnkey Sports, L.L.C., a Delaware limited liability company ("Assignor"), and Turnkey People LLC, a Delaware limited liability company ("Assignee"). WHEREAS, Assignor desires to sell, assign, and transfer all right, title and interest in and to the Trademark, together with the goodwill associated therewith;

WHEREAS, the Assignee is desirous of acquiring all right, title and interest in and to the Trademark, together with the goodwill associated therewith;

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein, the sufficiency of which are hereby acknowledged by both Parties, the undersigned Parties intending to be legally bound agree as follows:

1. The preamble shall form part of this Agreement and the representations and warranties of the Parties.
2. Assignment. Assignor hereby sells, assigns, and transfers all right, title and interest in and to the Trademark to Assignee, its successors, and assigns, including any renewals and extensions of the registration that are or may be secured, now or hereafter in effect, together with the goodwill associated therewith, and including (a) all income, royalties and rights to payment with respect to the Trademark; and (b) all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademark with the right to sue for, and collect for the same for Assignee's own use and enjoyment.
3. Further Assurances. Assignor shall do all acts and execute all documents that may be reasonably required by Assignee in order to effect the assignment of the Trademark.
