**INTELLECTUAL PROPERTY ASSIGNMENT**

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment") is entered into and dated as of November 19, 2019, by and among Western Digital Technologies, Inc. ("Seller"), HGST, Inc. ("Selling Entity," and together with Seller, the "Assignors," and each individually, an "Assignor") and DDN Firecrest, Inc. (the "Assignee").

WHEREAS, Assignee, Seller and DataDirect Networks, Inc. are parties to that certain Asset Purchase Agreement, dated as of September 19, 2019 (the "APA"), pursuant to which, among other things, Seller agreed to assign, or to cause one or more of the Selling Entities to assign, to Assignee and/or its Affiliates all of its or their rights, title and interest in and to the Seller Assigned IP (as defined below), including the assets set forth on Schedules A, B, and C attached hereto.

WHEREAS, Seller is the direct or indirect beneficial owner of all of the outstanding capital stock or other equity interests, as applicable, of Selling Entity.

NOW, THEREFORE, in order to consummate the transactions contemplated by the APA and for the consideration set forth therein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:

1. Capitalized Terms. Capitalized terms used but not defined in this Assignment shall have the meanings ascribed to such terms in the APA.

2. Assignment of Intellectual Property Rights. Assignors hereby irrevocably and unconditionally sell, assign, transfer, convey and deliver to Assignee and Assignee hereby acquires from such Assignors, all right, title, entitlement, and interest in, to and under all Intellectual Property Assets, including without limitation (a) the patents and patent applications identified in Schedule A (collectively, the "Patents") and all patent applications and patents derived therefrom and issuing therefrom, throughout the world, including without limitation, reissues, divisions, continuations, renewals, extensions, continuations-in-part, and reexaminations thereof in the United States (and their international counterparts); (b) the trademarks identified in Schedule B (collectively, the "Trademarks") together with (i) the goodwill of the business symbolized by and associated with the Trademarks and (ii) all applications for registration, registrations, renewals and statements of use with respect to the Trademarks, (c) the Internet domain names identified in Schedule C (collectively, the "Domain Names") and all registrations and renewals thereof, and (d) except to the extent subject to existing Encumbrances (including all existing licenses), all rights to collect royalties, and proceeds in connection with any of the foregoing Intellectual Property Assets, all rights to sue and bring other claims for, and recover damages in connection with, past, present and future infringement, misappropriation or other violation thereof, and all other claims relating to any such Intellectual Property Assets (regardless of whether arising prior to, as of, or after the date hereof, known or unknown), and all associated rights in, to or under any of the foregoing in any jurisdiction throughout the world, whether now or hereafter existing (collectively the "Seller Assigned IP").

3. Further Assurances. Assignors hereby covenants that they will, upon reasonable request by Assignee (or its successors or assigns), and at Assignee's sole costs and expense, do, execute, acknowledge and deliver any and all such other further acts, assignments, transfers, affidavits, declarations, oaths, exhibits, assignments, powers of attorney and/or other agreements or instruments of further assurance, approvals and consents as Assignee (or its successors or assigns) reasonably may require to assist Assignee's efforts to confirm, effect, record, perfect, or maintain, protect and enforce the rights assigned herein.

4. Power of Attorney. In the event Assignors are unavailable or unable to provide Assignee with further assistance as set forth in Section 3, Assignors hereby designate and appoint Assignee and its duly authorized officers and agents, as Assignors' agents and attorneys-in-fact to act for and on Assignors' behalf, solely to execute and file any such document or documents and to do all other lawfully permitted acts to confirm and perfect the rights assigned hereunder with the same legal force and effect as if executed by Assignors.

5. Miscellaneous.

(a) Terms of the APA. In the event of any conflict or inconsistency between the terms of the APA and the terms of this Assignment, the terms of the APA shall govern.

(b) Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).

(c) Severability. If any term or other provision of this Assignment is invalid, illegal, or incapable of being enforced by any law or public policy, all other terms or provisions of this Assignment shall nevertheless remain in full force and effect so long as the economic or legal substance of the transfer of the Seller Assigned IP is not affected in any manner materially adverse to any party. Upon such determination that any term or other provision is invalid, illegal, or incapable of being enforced, the parties hereto shall negotiate in good faith to modify this Assignment so as to effect the original intent of the parties as closely as possible in an acceptable manner in order that the transfer of the Seller Assigned IP is consummated as originally contemplated to the greatest extent possible.

(d) Counterparts. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement. A facsimile or emailed copy of this Assignment signed by the parties may be treated as an original for all purposes.
