**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 20, 2017 (the “Trademark Security Agreement”) with Agent, notice of which was recorded on July 20, 2017 at the United States Patent and Trademark Office at Reel 6110, Frame 0035.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of its Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


