**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “Release”) is dated as of December 19, 2019 and delivered by Royal Bank of Canada, in its capacity as Collateral Agent for the benefit of the Secured Parties under the Second Lien Security Agreement referred to below (in such capacity, the “Agent”), in favor of LDiscovery, LLC, a Delaware limited liability company (“LD”), LDiscovery TX, LLC, a Delaware limited liability company (“LDTX”) and Kroll Ontrack, LLC, a Minnesota limited liability company (“Kroll”, and together with LD and LDTX, the “Grantors” and each a “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Second Lien Security Agreement (as defined below) or the IP Security Agreement (as defined below), as applicable.

**WHEREAS**, pursuant to that certain Second Lien Security Agreement, dated as of December 9, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among LD Intermediate Holdings, Inc., a Delaware corporation, LD Lower Holdings, Inc., a Delaware corporation, LD Topco, Inc., a Delaware corporation, WVLD Acquisition Corp., a Delaware corporation, LDisc Holdings, LLC, a Delaware limited liability company, Engenium Corporation, a Texas corporation, the Grantors and the Agent, in order to secure payments of certain Secured Obligations, the Grantor was required to execute and deliver a Second Lien Intellectual Property Security Agreement, dated as of December 9, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”) and pursuant thereto each Grantor assigned, pledged and granted to the Agent, for the benefit of the Secured Parties, a continuing security interest in all of such Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including without limitation those (i) Trademarks listed on Schedule I hereto, (ii) Patents listed on Schedule II hereto and (iii) Copyrights listed on Schedule III hereto.

**WHEREAS**, pursuant to the IP Security Agreement, a security interest in the Trademarks was recorded with the United States Patent and Trademark Office on December 9, 2016, at Reel 5944, Frame 0500.

**WHEREAS**, pursuant to the IP Security Agreement, a security interest in the Patents was recorded with the United States Patent and Trademark Office on December 9, 2016, at Reel 040960, Frame 0728.

**WHEREAS**, pursuant to the IP Security Agreement, a security interest in the Copyrights was recorded with the United States Copyright Office on December 13, 2016, at Volume 9946, Document 342.

**WHEREAS**, the Agent acknowledges the full payment and performance of the Secured Obligations, and as a result desires to terminate and release the entirety of any security interest it may have in the Intellectual Property Collateral.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself and the Secured Parties, hereby fully terminates, releases, cancels and forever discharges any and all security interests it has in the Intellectual Property Collateral, terminates the IP Security Agreement, and retransfers, re-conveys and reassigns to the Grantors, as

applicable, and without representation or warranty of any kind, express or implied, free and clear of any claims by the Agent, all right, title or interest of the Agent (if any) in, to or under the Intellectual Property Collateral. The Agent hereby authorizes and requests that the United States Patent and Trademark Office and the Register of Copyrights note and record this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
