**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of November 25, 2019 (“Release”), is made by **FIDUS MEZZANINE CAPITAL, L.P.**, a Delaware limited partnership, as Collateral Agent (“Collateral Agent”) in favor of **MEDIFLEET, LLC**, a Connecticut limited liability company (“Pledgor”), pursuant to that certain Amended and Restated Pledge and Security Agreement dated September 28, 2017 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”);

**WHEREAS**, in connection with the Security Agreement, Pledgor executed and delivered a certain Grant of Security Interest in Patents and Trademarks, which is recorded at the United States Patent and Trademark Office (“USPTO”) on September 28, 2017 at Reel 6163/Frame 0112 and a certain Restated Grant of Security Interest in Patents and Trademarks, which was recorded at the USPTO on March 29, 2018 at Reel 6303/Frame 0030 (“Notices”), whereby Pledgor granted to Collateral Agent, a continuing security interest in any and all of Pledgor’s right, title, and interest in and to Trademarks and Patents, including those Trademarks and Patents listed on Schedule A attached hereto;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent and Pledgor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, without representation, warranty, or recourse, hereby irrevocably terminates, cancels, discharges, and releases the continuing security interest in Pledgor’s right, title, and interest in and to the Trademarks and the Patents granted pursuant to the Security Agreement and the Notices. The Collateral Agent hereby authorizes the Pledgor, and any of their designees, to file this Release with the United States Patent and Trademark Office to evidence the release and termination of the security interest in the Trademarks and Patents contemplated hereby.
