Notice of Release of Security Interest in Trademarks

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 23, 2019 (this "Notice of Release"), is made by CREDIT SUISSE AG, Cayman Islands Branch, as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of West Claims Recovery Services, LLC, a Delaware limited liability company (the "Pledgor"). Unless otherwise provided herein, capitalized terms used and not defined herein have the meanings given such terms in the Security Interest Notice or Collateral Agreement (as defined below). The rules of construction specified in Section 1.01(b) of the Collateral Agreement also apply to this Notice of Release.

WHEREAS, pursuant to the Collateral Agreement (First Lien), dated as of October 10, 2017 (as may have been amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among West Corporation, each of its subsidiaries identified therein and Collateral Agent, the Pledgor executed and delivered to Collateral Agent a Notice of Grant of Security Interest in Trademarks, dated as of October 10, 2017 (the "Security Interest Notice"), which was recorded in the United States Patent and Trademark Office on October 10, 2017 at Reel/Frame 6179/0210;

WHEREAS, pursuant to the Collateral Agreement and the Security Interest Notice, Pledgor assigned and pledged to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a continuing security interest in all of such Pledgor's right, title and interest in, to and under all Trademarks, including those listed on Schedule I, but excluding any "intent-to-use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. §1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of the Lanham Act has been filed, to the extent, if any, that any assignment of an "intent-to-use" application prior to such filing would violate the Lanham Act (collectively, but excluding any other Excluded Property, the "Trademark Collateral"); and

WHEREAS, the Lenders and the Secured Parties have authorized the Collateral Agent to release the security interest in the Trademark Collateral as specified below, and in furtherance thereof, the Collateral Agent executed and delivered a Guarantee and Lien Release, dated as of December 23, 2019, in favor of Pledgor (the "Guarantee and Lien Release"), which provided for the execution of this Notice of Release, and authorized the recordation of this Notice of Release with the United States Patent and Trademark Office, upon consummation of the Transaction (as defined in the Guarantee and Lien Release);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby releases, discharges and terminates its security interest in the Trademark Collateral and hereby reassigns to the Pledgor any right, title and interest the Collateral Agent may have in the Trademark Collateral, including all goodwill of the business symbolized by such Trademark Collateral, in each case effective upon the consummation of the Transaction and without recourse to, or representation or warranty by, the Collateral Agent.




