Trademark Security Interest Release

1. All security interests granted pursuant to the Security Agreement are hereby released. Secured Party hereby re-conveys to Company, without recourse or warranty, all Secured Party's right, title, claim and interest in and to the Trademarks, all proceeds thereof, all rights corresponding thereto including but not limited to all renewals, and extensions thereof, and the recordings and applications therefor.
