Trademark Security Interest Release

This Trademark Security Interest Release ("Release") is made as of December 23, 2019 by Western Alliance Bank, an Arizona corporation (the "Secured Party"), in favor of ExploreTrip, Inc., a Delaware corporation, with an address 4000 E 3rd Ave., Suite 650, Foster City, Delaware 94404 ("Company").

WHEREAS, Company executed a Security Agreement on September 7, 2017 ("Security Agreement") granting a security interest to Secured Party in United States Trademark Reg. No. 5,358,706 for the mark ExploreTrip ("the Trademark");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on September 7, 2017 at Reel/Frame 6149/0108;


WHEREAS, Company has satisfied its obligations under the Security Agreement; and

WHEREAS, Secured Party has agreed to release all its rights in the Trademark and re-convey any and all rights it may have acquired in the Trademark to Company:

NOW, THEREFORE, for good and value consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

1. All security interests granted pursuant to the Security Agreement are hereby released. Secured Party hereby re-conveys to Company, without recourse or warranty, all Secured Party's right, title, claim and interest in and to the Trademark, all proceeds thereof, all rights corresponding thereto including but not limited to all renewals, and extensions thereof, and the recordings and applications therefor.
