**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “Trademark Release”) is made as of December 23, 2019, by **GOLUB CAPITAL LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, the “Collateral Agent”) in favor of **RECORDXTECHNOLOGIES, LLC** (f/k/a KEAIS RECORDS SERVICE, LLC), a Delaware limited liability company (“RecordXTechnologies”) and **SECOND IMAGE NATIONAL, LLC**, a California limited liability company (“Second Image National”, and together with RecordXTechnologies, each, a Grantor and collectively, the “Grantors”), each with an address at 910 Louisiana Street, Suite 4500, Houston, Texas 77002. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, the Grantors, the Collateral Agent, and the other Persons party thereto entered into that certain Security Agreement dated as of October 31, 2018 (as may have been amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, the Grantors also entered that certain Trademark Security Agreement, dated as of October 31, 2018 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on November 20, 2018 at the United States Patent and Trademark Office at Reel 6486, Frame 0565.

WHEREAS, each Grantor granted to the Collateral Agent, pursuant to the terms of the Security Agreement and the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in to and under the Trademark Collateral of such Grantor, whether then existing or thereafter created or acquired, including without limitation the Trademark registrations and Trademark applications referred to in **Schedule A**, (the “Released Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Released Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges its Security Interest in the Released Collateral, and hereby assigns, transfers and conveys to the applicable Grantor any right, title or interest the Collateral Agent may have in the Released Collateral of such Grantor, in each case without representation, warranty or recourse by or to Collateral Agent.
