**RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This Release of Trademark Security Agreement (“Release”) is made as of December 23, 2019, by **GOLUB CAPITAL MARKETS LLC**, a Delaware limited liability company (the “Administrative Agent”) in favor of **SPRINGBROOK HOLDING COMPANY, LLC**, a Delaware limited liability company with an address at 1000 SW Broadway, Suite 1900, Portland, Oregon 97205 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated October 2, 2019 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on October 2, 2019 at the United States Patent and Trademark Office at Reel 6761, Frame 0361.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of such Grantor’s right, title and interest in, to and under all the Collateral, including the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in the Collateral, including the Trademarks listed in **Schedule A** (the “Released Collateral”) as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Released Collateral, and assigns, transfers and conveys to Grantor the Security Interest in such Released Collateral.
