



GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, INVNT, LLC, a Delaware limited liability company (the "**Borrower**"), FURY EVENTS HOLDING COMPANY, LLC, a Delaware limited liability company (the "**Parent**") and the direct parent entity of the Borrower, HEVE LLC, a Delaware limited liability company ("**heve**"), INVNT FSTVLS, LLC, a Delaware limited liability company ("**FSTVLS**"), each of the other domestic Subsidiaries of the Parent from time to time party hereto (Parent, heve, FSTVLS and each such domestic Subsidiary of the Parent, individually a "**Guarantor**" and collectively, the "**Guarantors**"; the Guarantors and the Borrower are referred to herein individually as a "**Grantor**" and collectively as the "**Grantors**"), and MB CAPITAL FUND IV, LLC (the "**Secured Party**") are parties to a Security Agreement, dated as of December [], 2019 (as amended supplemented or otherwise modified from time to time, the "**Security Agreement**"). - a. the trademarks and registrations thereof, including the trademarks listed on Schedule 1 attached hereto (collectively, the "**Trademarks**");
- b. the goodwill of the business symbolized by the Trademarks; and
- c. all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof.


