Pursuant to Section 1003 of the Limited Liability Company Law, each of the undersigned hereby certifies as follows:

**FIRST:** The name (and if the name has been changed, the name under which it was formed) and jurisdiction of formation or organization of each domestic limited liability company or other business entity that is to merge is:

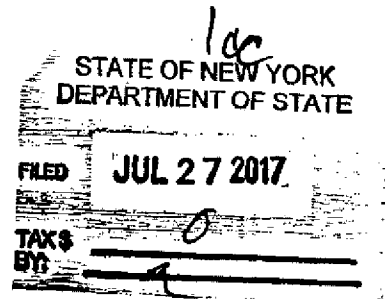
