## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of December 26, 2019 in favor of MMM HOLDINGS, LLC (f/k/a MMM Holdings, Inc.), a Puerto Rico limited liability company (the "Grantor"), by BSP AGENCY, LLC, a Delaware limited liability company (the "Administrative Agent").

WHEREAS, Grantor and Administrative Agent are party to that certain Trademark Security Agreement dated as of March 15, 2018 (the "Security Agreement"; capitalized terms not defined herein shall have the meanings assigned to such terms in the Security Agreement), pursuant to which Grantor granted to Administrative Agent, a continuing security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired (collectively, the "Trademark Collateral"):

- (i) each Trademark of Grantor, including, without limitation, each Trademark, Trademark registration and Trademark application described on Schedule A, together with any and all (a) rights and privileges arising under applicable law with respect to the use or ownership of any of the foregoing, (b) goodwill associated therewith, and (c) continuations, extensions and renewals thereof and amendments thereto;
- (ii) all the Goodwill associated with the foregoing; and
- (iii) all Proceeds of any of the foregoing (other than Excluded Property);

WHEREAS, Administrative Agent's lien and security interest in the Trademark Collateral was recorded with the United States Patent and Trademark Office on March 15, 2018 at Reel/Frame 6292/0322; and

WHEREAS, Administrative Agent wishes to terminate, cancel and release all liens and security interests it has in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates, cancels, releases and conveys all liens and security interests it has in and to the Trademark Collateral to Grantor.

Administrative Agent shall take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
