**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 20, 2019 ("Release"), is made by Fifth Third Bank, National Association, as Agent ("Agent") in favor of Guardian Interlock, LLC, a Georgia limited liability company ("Debtor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 8, 2019 by and among the Debtor and Agent ("Trademark Security Agreement"), Debtor granted to, and created in favor of, Agent, for the benefit of the Secured Creditors, a continuing security interest in, and Lien on all of such Debtor's right, title and interest in, to, and under all Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on August 8, 2019 at Reel 6716 Frame 0146.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Creditors, and Debtor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Creditors, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and Lien on all of such Debtor's right, title and interest in, to, and under all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Debtor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Ohio.
