**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 20, 2019 ("Release"), is made by Fifth Third Bank, National Association, for itself and as agent for each affiliate of Fifth Third Bancorp (collectively, the "Secured Party"), in favor of #1 A LifeSafer, Inc. (formerly known as LifeSafer Interlock, Inc.), a Kentucky corporation ("Debtor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of December 20, 2011 by and among the Debtor and Secured Party ("Trademark Security Agreement"), Debtor granted to Secured Party a continuing security interest in and to, and a Lien on all of the Trademark Collateral, and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on December 22, 2011 at Reel 4686 Frame 0165.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Debtor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

**SECTION 2. Termination and Release.** Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and Lien on all of the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Debtor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Ohio.

**IN WITNESS WHEREOF**, the Secured Party has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
