**MEMORANDUM AND NOTICE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

ADC SOLUTIONS USA, LLC, a Delaware limited liability company (“Parent”), **ADC SOLUTIONS AUTO, LLC**, a Delaware limited liability company (“ADC Solutions Auto”) and **WINPLUS NORTH AMERICA, INC.**, a California corporation (“Winplus North America”); together with Parent and ADC Solutions Auto, each, a “Debtor” and collectively, the “Debtors”), hereby acknowledges that it has granted to **BANK OF AMERICA, N.A.**, a national banking association (“Lender”), whose address is 333 S. Hope Street, 19th Floor, Los Angeles, California 90071, a security interest in and to all of Debtors’ right, title and interest in and to the patents and patent registrations and applications therefor which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by each Debtor (the “Patents”), together with the goodwill and assets of the business, as set forth in the Loan Agreement (as defined below).

Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Lender may have in any other collateral described in the Loan Agreement, the Security Agreement or otherwise.




