## TRADE MARK ASSIGNMENT

This Assignment is made the 25 day of November 2019.

BETWEEN

### WHEREAS

- (B) The Assignor has agreed to assign unto the Assignee the whole of the Assignor's interest, rights, and title in and to the Trade Marks.

### NOW THIS AGREEMENT WITNESSETH


In pursuance of the said agreement, and in consideration of the sum of £10 (ten pounds sterling) paid by the Assignee to the Assignor (the receipt of which the Assignor hereby acknowledges) the Assignor hereby assigns to the Assignee with full title guarantee all the Trade Marks and all the rights, powers, liberties and immunities arising or to arise from the Trade Marks, together with the goodwill of the business concerned in the goods for which the Trade Marks are registered, including the right to make any new application or applications in respect of any of the Trade Marks, and all rights to take proceedings as for any past infringement including the right to sue for damages and other remedies in respect of any act committed prior to the date hereof TO HOLD unto the Assignee absolutely.

The Assignment shall be construed in accordance with the laws of England and Wales and be subject to the exclusive jurisdiction of courts of England and Wales.
