RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN) (this "Release") dated as of December 27, 2019 is made by Credit Suisse AG, Cayman Islands Branch, as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent") in favor of Lionbridge Technologies, Inc., a Delaware corporation, Veritest, Inc., a Delaware corporation, and Geotext Translations, Inc., a New York corporation (each a "Grantor" and collectively the "Grantors"). Capitalized terms not defined herein shall have the meaning ascribed to them in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS pursuant to the Second Lien Guaranty and Security Agreement dated as of February 28, 2017 in favor of the Collateral Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"), the Grantors agreed to guarantee the Guaranteed Obligations and to secure the Secured Obligations as provided therein;

WHEREAS, as required by the Guaranty and Security Agreement, the Grantors executed and delivered a Trademark Security Agreement, dated as of February 28, 2017, in favor of the Collateral Agent (the "Trademark Security Agreement"), pursuant to which each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing lien on and security interest in all of its right, title and interest in, to and under the following Collateral of such Grantor: (a) all of its Trademarks, including, without limitation, those United States Trademarks referred to on Schedule I hereto (but excluding any "intent to use" Trademark applications for which a statement of use or amendment to allege use had not been filed and accepted by the United States Patent and Trademark Office); (b) all renewals and extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 3, 2017 at Reel/Frame 6001/0126 (with respect to Lionbridge Technologies, Inc.), at Reel/Frame 6001/0256 (with respect to Geotext Translations, Inc.), and at Reel/Frame 6000/0737 (with respect to Veritest, Inc.);

WHEREAS the Collateral Agent now desires to terminate and release its security interest in the Trademark Collateral;

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby terminates and releases its lien on and security interest in the Trademark Collateral, and

hereby reassigns to each Grantor any right, title or interest the Collateral Agent may have in the Trademark Collateral of such Grantor, in each case without recourse to, or representation or warranty by, the Administrative Agent, the Collateral Agent, any Lender, any L/C Issuer or any other Secured Party.

The laws of the State of New York shall govern all matters arising out of, in connection with, or relating to this Release including, without limitation, its validity, interpretation, construction, performance and enforcement (including, without limitation, any claims based in contract or tort law arising out of the subject matter hereof).
