Assignor hereby assigns to Assignee all of its right, title and interest in and to the Marks, including any and all applications and registrations therefor, and including the goodwill of the business symbolized thereby, and all rights to sue, bring actions and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Marks.

2. Assignor authorizes and requests the United States Patent and Trademark Office to record Assignee as the owner of the entire worldwide right, title and interest in and to the Marks, for the sole use and enjoyment of Assignee.
