TERMINATION AND RELEASE OF TRADEMARK COLLATERAL AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK COLLATERAL AGREEMENT (this "Termination"), is dated as of December 30, 2019, and made by **TRUIST BANK** (as successor by merger to SunTrust Bank), as agent (the "Grantee"), to **INFLUENCE HEALTH, INC.**, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Collateral Agreement dated as of February 5, 2019 by the Grantor in favor of the Grantee (the "Collateral Agreement"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Collateral Agreement was recorded at the United States Patent and Trademark Office on February 5, 2019 at Reel/Frame 6551 / 0428; and

WHEREAS, Grantee now desires to terminate and release the Collateral Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Trademark Collateral" as used herein, shall have the meaning set forth in the Collateral Agreement, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Collateral Agreement and terminates, releases and discharges its lien on and security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
