PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Partial Release") is granted as of December 30, 2019 by PNC BANK, NATIONAL ASSOCIATION (the "Grantee"), in favor of SOCK AND ACCESSORY BRANDS GLOBAL, INC. a Delaware corporation ("SABG"), TWIN CITY KNITTING COMPANY, INC., a North Carolina corporation ("TCKC") and ARGYLE HOLDINGS, INC., a Delaware corporation ("Holdings", and together with SABG and TCKC, each a "Grantor" and collectively, the "Grantors").

WHEREAS, the Grantors have executed and delivered to the Grantee an Intellectual Property Security Agreement, dated as of April 18, 2018 (the "IP Security Agreement"), which was recorded with the United States Patent and Trademark Office (the "PTO") on April 23, 2018, at Reel 6319 and Frame 0114, et seq.;

WHEREAS, pursuant to Grantee's letter to SABG of even date herewith, entitled Re: Consent to Asset Purchase Agreement (the "Release"), Grantee has consented to that certain Asset Purchase Agreement dated as of the date hereof (the "Purchase Agreement"), pursuant to which GCE International Inc. is acquiring certain assets of SABG, including but not limited to the intellectual property set forth on Schedule A attached hereto (the "Specified Intellectual Property Collateral"); and

WHEREAS, pursuant to the Release, Grantee has released Grantee's liens and security in the Purchased Assets (as defined in the Purchase Agreement) and including but not limited to the Specified Intellectual Property Collateral and has further agreed release and discharge fully its interest in the Specified Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby release and discharge, without any representation or warranty, any and all liens and security interests and all right, title and interest that Grantee may have in and to the Specified Intellectual Property Collateral.

The Grantee hereby authorizes and requests that the PTO note and record the present Partial Release.

Except for the release of Specified Intellectual Property Collateral specifically identified on Schedule A attached hereto, all terms and provisions of the IP Security Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Trademark Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. **Any lien and/or security interest granted in any trademarks pursuant to the IP Security Agreement or any related agreement shall remain unchanged and in full force and effect except as specifically released hereby.**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.






