TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 31, 2019, by CAPITAL ONE, N.A. (as successor-in-interest by merger to Healthcare Financial Solutions, LLC, successor to General Electric Capital Corporation), in its capacity as administrative agent (in such capacity, "Agent") in favor of CLP HEALTHCARE SERVICES, INC. ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Grantor and General Electric Capital Corporation were parties to that certain Trademark Security Agreement dated as of December 22, 2014, which was recorded with the United States Patent and Trademark Office on January 2, 2015 (the "Security Agreement"), pursuant to which Grantor granted to General Electric Capital Corporation a security interest in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to General Electric Capital Corporation, as administrative agent, and the other Secured Parties, including the Trademarks and Trademark Collateral set forth on Schedule 1 annexed hereto;

WHEREAS, pursuant to that certain Assignment of Intellectual Property Security Agreement by and between General Electric Capital Corporation and Agent, dated as of November 20, 2015, which was received with the United States Patent and Trademark Office on November 23, 2015, General Electric Capital Corporation assigned and transferred to Agent and its successors and assigns, all of its rights, title and interest in and to the Security Agreement to Healthcare Financial Solutions, LLC;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 23, 2015 at Reel/Frame 5674/0694; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, terminates and discharges its security interest in all of Grantor's right, title and interest in, to and under the following (collectively the "Trademark Collateral");

(a) all of its Trademarks (other than any "intent to use" Trademark applications for which a statement of use has not been filed and accepted with the U.S. Patent and Trademark Office), including, without limitation, those referred to on Schedule 1 hereto;

(b) all renewals, reversions and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in, to and under the Trademarks and the Trademark Collateral.
