TRADEMARK ASSIGNMENT AGREEMENT

Assignor and Assignee acknowledge and agree that Assignee is a successor of the entire business or portion thereof to which the Marks pertain, which business is ongoing and existing.

2. Entire Agreement. This Agreement constitutes the entire understanding of the parties, and supersedes any prior agreements or communications, concerning the subject matter described herein and therein.

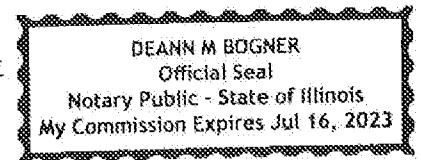
