# TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT (UNITED STATES)

THIS TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT (this "<u>Agreement</u>") is made and entered into effective as of December 31, 2019 (the "<u>Effective Date</u>") by and between TBG IP Holder, LLC, a Delaware limited liability company ("<u>TBG IP Holder</u>") and Avant Partners, Inc., in its sole and limited capacity as assignee for the benefit of creditors of TBG IP Holder ("<u>ABC Assignee</u>" and collectively with TBG IP Holder, "<u>Assignor</u>") and Regis Corp., a Minnesota corporation ("<u>Regis Assignee</u>"). Assignor and Regis Assignee are referred to individually as a "<u>Party</u>" and collectively as the "<u>Parties</u>".

WHEREAS, Assignor owns all rights, title, and interests, in and to the trademarks identified in the attached <u>Schedule A</u>, together with any and all trademark registrations and applications therefor and common law rights of Assignor in the trademarks that are the subject of such registrations and applications (the "<u>Marks</u>");

WHEREAS, Assignor also owns the Internet domain names identified in the attached Schedule A (the "Domain Names") and is the registrant of record for the Domain Names;

WHEREAS, pursuant to that certain Portfolio Transfer Agreement (United States) dated as of December 30, 2019 (as amended, restated, supplemented, or otherwise modified from time to time), by and among Assignor, Regis Assignee, and the other parties thereto, Assignor agreed to transfer the Marks to Regis Assignee; and

WHEREAS, Regis Assignee desires to acquire from Assignor, and Assignor wishes to transfer to Regis Assignee, all rights, title, and interests, in and to the Marks, the trademark goodwill associated with such Marks, and all registrations and applications for registration thereof, and the Parties wish to record such acquisition.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. Assignor does hereby assign, transfer, set over, and deliver to Regis Assignee all of the Assignor's rights, title, and interests, in and to:
  - (a) the Marks, including without limitation all registrations and applications thereof, all registrations which may be granted in respect of such applications, all renewals of such registrations, and all common law rights therein;
  - (b) the trademark goodwill of the business symbolized by such Marks;
  - (c) the right to bring suit and recover damages for past, present, and future infringement, dilution, misappropriation, violation, or unlawful imitation of such Marks;

- (d) the entire rights, title, and interests, in and to all convention and treaty rights of all kinds, including without limitation all rights of priority in any country of the world, in and to the above Marks; and
- (e) all prosecution history files for such trademark registrations and applications for trademark registration in the possession of Assignor, as well as records, prototypes, specimens, and materials contained in such files.
- 2. Assignor hereby assigns to Regis Assignee all of Assignor's rights, title, and interests in and to the Domain Names, all other corresponding rights that are or may hereafter be secured under the laws of the United States, any jurisdiction thereof, any foreign country or any multinational jurisdiction, now or hereafter in effect, all goodwill associated with the Domain Names and all content appearing as of the date hereof on the websites operated under the Domain Names (the Domain Names, all goodwill associated therewith and all content thereon, subject to any applicable licenses for such content, shall hereinafter collectively be referred to as the "Websites"), together with all rights to income, royalties and license fees deriving from the Websites, all claims for damages by reason of past, present and future infringements or unauthorized uses of any of the Websites and the right to sue for and collect such damages as permitted under the applicable laws of any jurisdiction or country in which such claims may be asserted for the use and benefit of Regis Assignee and its successors, assigns and other legal representatives.
- 3. Assignor hereby authorizes and requests the competent authorities to record this Agreement and to grant and issue any and all registrations of the Marks throughout the world to Regis Assignee, its successors, or assigns, whose rights, title, and interests in and to such registrations are the same as would have been held and enjoyed by Assignor had this Agreement not been made.
- 4. Assignor further agrees to execute and have executed all documents, instruments and papers and to perform all acts as deemed reasonably necessary by Regis Assignee to perfect in Regis Assignee the foregoing rights, title and interests, including executing further consistent assurances, confirmations, assignments, transfers and releases (including without limitation effectuating the transfer of the Domain Names with the registrar of the Domain Names by electronic confirmation or as otherwise required by such registrar, and promptly delivering copies of the completed registrar transfer confirmations to Regis Assignee), and providing good faith testimony by affidavit, declaration, deposition or other means. Assignor will not oppose or otherwise impede any effort by Regis Assignee to enforce or procure registration for the Marks before any administrative, government or other tribunal. Assignor and its directors, officers and employees shall provide all assistance reasonably requested by Regis Assignee necessary to document and confirm Assignor's assignment of the Websites to Regis Assignee.
- 5. This Agreement will be binding upon the Parties and their successors and assigns.
- 6. This Agreement may be executed simultaneously in two or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same

instrument. This Agreement may be executed by facsimile or .pdf signature, and a facsimile or .pdf signature will constitute an original for all purposes.


