RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of December 31, 2019, is made by **MONROE CAPITAL MANAGEMENT ADVISORS, LLC**, a Delaware limited liability company, in its capacity as administrative agent for the Lenders ("Secured Party"), and is as follows:

WHEREAS, Yandy, LLC, an Arizona limited liability company ("Debtor"), and Secured Party are parties to (i) that certain Trademark Security Agreement dated as of September 30, 2014 and (ii) that certain Trademark Security Agreement dated as of March 25, 2019, which were both recorded with the United States Patent and Trademark Office (collectively, the "Agreements"); capitalized terms used but not defined herein will have the meaning given to them in the Agreements;

WHEREAS, the Agreements granted to Secured Party a security interest in all of Debtor's right, title and interest in, to and under the Trademark Collateral, including, without limitation: (a) all of Debtor's trademarks and trademark intellectual property licenses to which it is a party, including, without limitation, those referred to on Schedule I attached hereto; (b) all renewals, reissues, continuations, and extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark intellectual property license; and (d) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by such Debtor against third parties for past, present or future (i) infringement or dilution of any trademark or any trademarks exclusively licensed under any intellectual property license, including any right to receive any damages, (ii) injury to the goodwill associated with any trademark, or (iii) right to receive license fees, royalties, and other compensation under any trademark intellectual property license; and


WHEREAS, Secured Party desires to release its rights and security interests in, and liens on, the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (i) its security interest in, liens on, and other rights, title and interest, if any, in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreements.
