**RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK COLLATERAL, dated as of December 31, 2019 (this “Release”), is made by **CITIZENS BANK, N.A.** (as successor by merger to Citizens Bank of Pennsylvania), in its capacity as administrative agent and collateral agent pursuant to the Credit Agreement (as defined in the ABL Security Agreement) (in such capacity, the “Collateral Agent”), in favor of **AIRXCEL, INC.** (the “Grantor”), as follows.

W I T N E S S E T H

WHEREAS, the Grantor is party to an ABL Pledge and Security Agreement dated as of April 27, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “ABL Security Agreement”) in favor of the Collateral Agent pursuant to which the Grantor executed and delivered the trademark security agreement described below;

WHEREAS, pursuant to that certain ABL Trademark Security Agreement, dated as of April 27, 2018, and recorded with the U.S. Patent and Trademark Office on April 30, 2019, at Reel/Frame No. 6341/0648 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “ABL Trademark Security Agreement”), the Grantor granted to the Collateral Agent a continuing security interest in all right, title or interest in, to or under, the IP Collateral (as defined in the ABL Trademark Security Agreement) described therein, including, without limitation, the United States trademark registrations and trademark registration applications set forth on Schedule A attached hereto (such registration and applications, the “Released Trademarks”);

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in the Released Trademarks;

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in the Released Trademarks as provided in this Release;

NOW, THEREFORE, the Collateral Agent, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without representation or warranty of any kind or nature, and at the Grantor’s sole cost and expense, hereby terminates, cancels, discharges and releases its security interest in all right, title and interest in, to or under the Released Trademarks.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release at the Grantor’s sole cost and expense.




