GRANT OF SECURITY INTEREST IN TRADEMARKS

GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Trademark Assignment"), dated as of December 30, 2019, by the undersigned (each, a "Grantor" and, collectively, the "Grantors"), in favor of WHITE OAK COMMERCIAL FINANCE, LLC (the "Agent").

WITNESSETH:

WHEREAS, reference is made to that certain (i) Security Agreement (including all exhibits and schedules thereto and as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "US Security Agreement"), dated as of the date hereof made by and among NYGÅRD HOLDINGS (USA) LIMITED, NYGARD INC., FASHION VENTURES, INC., NYGARD NY RETAIL, LLC and each of the other entities listed on the signature pages thereto or from time to time party thereto by execution of a joinder agreement, as pledgors, assignors and debtors, in favor of the Agent, and (ii) Canadian Security and Pledge Agreement (including all exhibits and schedules thereto and as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Canadian Security Agreement" and, together with the US Security Agreement, the "Security Agreements"), dated as of the date hereof made by and among NYGARD ENTERPRISES LTD., NYGARD PROPERTIES LTD., NYGARD INTERNATIONAL PARTNERSHIP, the other entities signatory thereto as grantors and each of the other entities listed on the signature pages thereto or from time to time party thereto by execution of a joinder agreement, as pledgors, assignors and debtors, in favor of the Agent.

WHEREAS, the Grantors are required to execute and deliver to the Agent this Trademark Assignment for the benefit of the Credit Parties.

NOW, THEREFORE, in consideration of the promises and mutual covenants herein contained and in the Security Agreements and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby agree as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Security Agreements, as applicable.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. As security for the payment and performance in full of the Secured Obligations, the Grantors hereby grant to the Agent and their successors and assigns, for the benefit of the Credit Parties, a continuing lien on and security interest in all of such Grantors' right, title and interest in, to and under any Trademarks and Licenses with respect to Trademarks constituting Collateral owned by the Grantors, along with all goodwill associated therewith (collectively, the "Trademark Collateral"), whether now owned or existing or hereafter acquired or arising and wherever located, including all Trademarks set forth in Schedule I, provided that no lien or security interest shall be granted on any trademark or service mark consisting of an "intent to

use” application until such time as an amendment to allege use in respect thereof has been accepted by the United States Patent and Trademark Office.

3. SECURITY AGREEMENTS. The liens and security interests granted pursuant to this Trademark Assignment are granted in furtherance, and not in limitation, of the liens and security interests granted to the Agent, for the benefit of the Credit Parties, as security for the payment and performance in full of the Secured Obligations, pursuant to the Security Agreements, as applicable. The Grantors hereby acknowledge and affirm that the rights and remedies of the Agent with respect to the liens on and security interests in the Trademark Collateral granted hereby are more fully set forth in the Security Agreements, as applicable, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Assignment conflicts with the applicable Security Agreement, the provisions of the applicable Security Agreement shall control.

4. COUNTERPARTS. This Trademark Assignment may be executed in any number of counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Trademark Assignment by telecopy, pdf or other electronic transmission shall be as effective as delivery of a manually executed counterpart of this Trademark Assignment.

5. TERMINATION OR RELEASE. This Trademark Assignment shall terminate and the liens and security interests granted hereby shall be automatically released in accordance with the provisions set forth in Section 9.5 of the US Security Agreement and Section 8.16 of the Canadian Security Agreement, as applicable.

6. GOVERNING LAW. THIS TRADEMARK ASSIGNMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO PRINCIPLES OF CONFLICTS OF LAWS THEREOF, BUT INCLUDING SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW.






