## CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, Haven Life Insurance Agency, LLC, a limited liability company duly organized and existing under the laws of Delaware, and having a place of business at 60 Madison Avenue, 7th Floor, New York, New York 10010 USA (hereinafter "ASSIGNOR"), has adopted and used the trademark COVERPATH in connection with "insurance agency and brokerage" services under U.S. Registration No. 4,537,236 (the "Trademark");

WHEREAS, ASSIGNOR was previously named Coverpath, Inc. and Haven Life Insurance Agency, Inc., but subsequently changed its name to Haven Life Insurance Agency, LLC;

WHEREAS, Massachusetts Mutual Life Insurance Company is a corporation duly organized and existing under the laws of Massachusetts, with a place of business at 1295 State Street, Springfield, Massachusetts 01111 USA (hereinafter "ASSIGNEE"); and

WHEREAS, ASSIGNEE acquired all right, title and interest in and to the Trademark, and all of the business and goodwill represented and symbolized by said Trademark, and desires now to record in the United States Patent and Trademark Office its said acquisition and ownership of the Trademark.

NOW, THEREFORE, IT IS HEREBY AGREED:

1. The "Confirmatory Trademark Assignment" signed by Coverpath, Inc. and ASSIGNEE on July 21, 2017, in which Coverpath, Inc. assigned the Trademark to ASSIGNEE, is now void.

2. In consideration of the sum of One Dollar (\$1.00) and other good valuable considerations to it in hand paid, the receipt of which is hereby acknowledged, ASSIGNOR irrevocably and unconditionally assigned and transferred, and does hereby irrevocably and unconditionally assign and transfer effective as of February 3, 2014 the entire right, title and interest in and to the Trademark, together with the goodwill of the business in connection with which the Trademark is used to ASSIGNEE.

3. ASSIGNOR shall do all acts and execute all documents which may be reasonably required by ASSIGNEE in order to effect the assignment of the Trademark and to ensure that applications shall proceed in the name of ASSIGNEE and that registrations be granted to ASSIGNEE.
