PARTIAL TERMINATION AND RELEASE OF LIEN IN INTELLECTUAL PROPERTY

THIS PARTIAL TERMINATION AND RELEASE OF LIEN IN INTELLECTUAL PROPERTY (this “Release”), is dated as of December 20, 2019, and made by and among PNC Bank, National Association (“Agent”) in its capacity as agent under the below-defined Security Agreement, and FKI Security Group, LLC, a Delaware limited liability company, Corporate Safe Specialists, LLC, a Delaware limited liability company, Fire King International, LLC, an Indiana limited liability company, Fire King Security Products, LLC, and Indiana limited liability company, Image Vault, LLC, an Indiana limited liability company, Fire King Commercial services, LLC, an Indiana limited liability company, and FK Acquisition, Inc., a Delaware corporation (collectively, “Grantors”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of March 30, 2015 (the “Security Agreement”), made by Grantors in favor of Agent, a security interest was granted by Grantors to Agent, in certain collateral, including the Specified IP Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (the “USPTO”) on October 30, 2015, at Reel 5662 and Frame 0605, and with the Patent Division of the USPTO on October 30, 2015, at Reel 036921 and Frame 0977;

WHEREAS, Agent now desires to terminate and release its security interest in the Specified IP Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Agent hereby states as follows:


1. Definitions. The term “Specified IP Collateral,” as used herein, means all of the Grantors’ right, title and interest in the intellectual property listed on Schedule A hereto.

2. Release of Security Interest. Agent hereby terminates, releases and discharges its security interest in the Specified IP Collateral and reassigns to the person or persons legally entitled thereto all of its right, title and interest in the Specified IP Collateral. Agent acknowledges that this Release may be filed with the United States Patent and Trademark Office or any other governmental office to evidence the partial termination and release granted by this Release.
