Secured Party agrees that, upon the request of the Borrower or any successor in interest or assignee thereof, and at the expense of the Borrower, Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Borrower, or any successor in interest or assignee thereof, to effectuate the release of interests contemplated herein.
