TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of December 10, 2019, by Ares Capital Corporation, as administrative agent (in such capacity, together with its successors and permitted assigns, "Grantee") for the Lenders and the L/C Issuers and the other Secured Parties in favor of LBP Manufacturing LLC, a Delaware limited liability company ("Grantor"). Capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Trademark Security Agreement (as that agreement is hereinafter defined).

W I T N E S S E T H:

WHEREAS, pursuant to the Guaranty and Security Agreement, dated as of July 2015 (the "Guaranty and Security Agreement"), Grantor granted a security interest (the "Security Interest") to Grantee in certain collateral;

WHEREAS, Grantor and Grantee entered into that certain Trademark Security Agreement, dated as of April 4, 2017 (the "Trademark Security Agreement") pursuant to which, by reference to the Guaranty and Security Agreement, Grantor reaffirmed its intent to grant the Security Interest to the Grantee specifically in the Trademark Collateral (as that term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on April 4, 2017, at Reel 6031, Frame 0380; and

WHEREAS, Grantor has requested that Grantee release its Security Interest in the Trademark Collateral, including the trademarks set forth on Schedule A attached hereto, and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases and terminates its Security Interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, including, without limitation, the trademarks referred to on Schedule A hereto.


2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Trademark Collateral, including, without limitation, the trademarks referred to on Schedule A hereto, and authorizes the recordation of this Trademark Release with the United States Patent and Trademark Office at the expense of the Credit Parties.

3. This Trademark Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
