**ARTICLES OF MERGER  
OF  
MEDITURE LLC  
(a Minnesota limited liability company)  
WITH AND INTO  
TRHC OPKO, INC.  
(a Delaware corporation)**

The undersigned hereby adopt these Articles of Merger pursuant to the provisions of Minnesota Statutes, Section 322C.1004 and Section 264(c) of the Delaware General Corporation Law (the "DGCL").

1. The name, form and jurisdiction of the constituent organizations that are parties to the merger are:

TRHC OpCo, Inc.	Corporation	Delaware

2. The surviving entity shall be TRHC OpCo, Inc., a Delaware corporation, which shall continue its existence as the surviving entity.

3. The merger shall be effective on January 1, 2020 at 12:00 a.m.

4. The Certificate of Incorporation of TRHC OpCo, Inc. upon the effective date of the merger in the jurisdiction of its organization shall be the Certificate of Incorporation of the surviving entity, and said Certificate of Incorporation shall continue in full force and effect until amended and changed in the manner prescribed by the provision of the Delaware General Corporation Law.

5. The merger was approved by (i) the sole member of eClusive L. L. C. in the manner prescribed by Minnesota Statutes, Section 322C.1003 and (ii) the board of directors and the sole stockholder of TRHC OpCo, Inc. in the manner prescribed by Sections 141(f) and 228(a), respectively, of the DGCL.

The surviving entity consents to the jurisdiction of the courts of Minnesota to enforce any debt, obligation, or other liability owed by any constituent entity of the State of Minnesota which is to merge, and hereby appoints the Secretary of State of the State of Minnesota (the "Secretary of State") as its agent to accept service of process in any such proceeding.
