**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of January 3, 2020 (the "Release"), is made by AVIDBANK CORPORATE FINANCE, A DIVISION OF AVIDBANK, a California corporation (the "Bank"), in favor of YOGA WORKS, INC., a California corporation (the "Grantor"). WHEREAS, the Grantor has requested that the Bank release its security interest in all right, title and interest in the intellectual property.

NOW, THEREFORE, in consideration of the foregoing, the Bank hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the intellectual property, including the copyright registrations, trademark registrations, and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the intellectual property is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Bank may have obtained in, to and under the intellectual property under the Loan Agreement and the Intellectual Property Security Agreement.
