## TRADEMARK ASSIGNMENT

**THIS ASSIGNMENT AGREEMENT** is dated as of November 1, 2019 by and between POOF-Slinky Fundex, LLC, a limited liability company registered in Delaware, with offices at 40 Lane Road, Fairfield, NJ 07004, United States ("Assignor") and James Routzong ("Assignee"), an individual having an address at 7 Sea Fox Lane, Gloucester, MA 01930.

### THE PARTIES HAVE DECLARED AND AGREED as follows

1. The game known as Don't Tip the Waiter was invented and originally trademarked by James Routzong. Assignee and Delaney Product Development entered into a License Agreement for the game known as Don't Tip the Waiter effective October 1, 2007 with Fundex Games, Ltd, a predecessor in interest to Assignor, and such License Agreement was terminated effective August 12, 2019.
2. Assignor is currently the registered owner of the trademark for Don't Tip the Waiter registered in the USPTO trademark under Serial Number 85179079 (the "Trademark").
3. In consideration of a sum of at least one dollar (\$1.00) and other good and valuable consideration, the receipt of which is acknowledged, Assignor assigns to Assignee 100% of its right, title, and interest in the Trademark, together with the goodwill of the business connected with the use of the mark, for the entire term of the registration and any extensions that may issue therefrom.
4. The right, title, interest and goodwill conveyed in this Assignment is to be held and enjoyed by Assignee and its successors as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.
5. The Assignment by Assignor takes place on a "as is where is" basis without any representation or warranty of any kind or nature express or implied.
6. This Assignment shall be governed by the laws of the State of New Jersey and the parties hereto submit to the jurisdiction of the State of New Jersey.
