INTELLECTUAL PROPERTY ASSIGNMENT

This Agreement is entered into by and among Tire Mart, Inc. and Tire Mart Holdings, Inc., each a Missouri corporation having an address of 1815 Locus Street, St. Louis, Missouri 63103 (collectively "Tire Mart"), and Pit Bull Brands, LLC, a Missouri limited liability company having an address of 1134 Nooning Tree Drive, Chesterfield, Missouri 63017 ("Pit Bull") (collectively the "Parties", and respectively a "Party).

WHEREAS, Tire Mart owns all right, title, and interest in and to the Inventions set forth in the Exhibit A.

WHEREAS, Tire Mart owns all right, title, and interest in and to the Trademarks set forth in Exhibit B.

WHEREAS, Tire Mart owns all right, title, and interest in and to the Copyrights set forth in Exhibit C.

WHEREAS, being a successor business to Tire Mart, Pit Bull desires to acquire from Tire Mart, and Tire Mart wishes to transfer to Pit Bull, all right, title, and interest in and to the Inventions, Trademarks, and Copyrights.

NOW THEREFORE, for valid and sufficient consideration, the sufficiency of which is hereby acknowledged, the Parties, intending to be legally bound, represent and agree as set forth below. No other promises have been made to secure the signatures of the Parties to this Assignment.

1. Tire Mart hereby assigns to Pit Bull all right, title, and interest in and to the Inventions listed in Exhibit A, including any and all patents and patent applications listed in Exhibit A, and to all non-provisional applications, divisions, reissues, reexaminations, substitutions, continuations, continuations-in-part, and extensions thereof, together with all claims, causes of action and damages for past infringement, if any, of said patents and patent applications. Further, Tire Mart hereby assigns to Pit Bull all right, title, and interest to the invention disclosed in the patents and patent applications listed in Exhibit A throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for such inventions in Pit Bull's own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of such inventions, and all rights to register such inventions in appropriate registries.
2. Tire Mart hereby assigned to Pit Bull all right, title, and interest in and to the Trademarks listed in Exhibit B together with the goodwill of the business symbolized by the Trademarks, the corresponding U.S. and foreign trademark registrations for the Trademarks, and any other applications or registrations for the Trademarks, and any renewals thereof, and all common law rights associated with the Trademarks; the right to sue or otherwise recover for any and all past, present, and future infringement or dilution of the Trademarks; all income, royalties, damages, and other payments now and hereafter due and payable with respect to the Trademarks; and all other rights, whereby statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder.
3. Tire mart hereby assigns to Pit Bull all right, title, and interest in and to the Copyrights, including all copyright registrations, listed in Exhibit C, together with all rights to: (a) reproduce the

Copyrights; (b) create derivate works of the Copyrights and otherwise modify the Copyrights in any manner whatsoever; (c) distribute copies of the Copyrights by rental, lease, lending, sale, or other transfer of ownership; (d) apply for future registrations in the U.S. and worldwide of the Copyrights; (e) all claims for damages by reason of past infringement of the Copyrights; and (f) the rights to sue and collect for any past, present, and future infringement of the Copyrights.

4. This assignment is irrevocable, exclusive, worldwide, perpetual, transferable, fully paid, and royalty free. Tire Mart agrees to cooperate with Pit Bull in connection with obtaining legal protection or other rights relating to the Inventions and Trademarks, including the execution of all applications, letters, declarations, affidavits, consents, waivers, and other matters necessary to secure such protection, if any. Tire Mart further agrees to execute all documents, papers, forms, and authorizations to take any and all other actions that may be necessary for securing, completing, or vesting in Pit Bull full right, title, and interest in and to the Inventions and the Trademarks.
5. Tire Mart hereby requests that the United States Commissioner of Patents, and the corresponding entities or agencies in any application foreign countries, to record Pit Bull as the sole owner of the Inventions. Tire Mart hereby requests that the United States Commissioner of Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Pit Bull as the sole owner of the Trademarks. Tire Mart hereby requests that the Register of Copyrights, and the corresponding entities or agencies in any applicable foreign countries, to record Pit Bull as the sole owner of the Trademarks.
6. This Assignment does not create any agency, employment, or partnership relationship between the Parties.
7. This Assignment is an integrated agreement that contains the entire understanding between the Parties regarding the matters addressed herein and may not be amended, extended or otherwise modified except by written agreement of all the Parties. This Assignment shall prevail over all prior communications between and among the Parties or their representatives regarding the matters addressed herein.
8. Should any provision of this Assignment be determined to be void, unenforceable, or against public policy, such provision may be altered in time or scope in order to give effect to such provision. If such alteration is not possible, such provision shall be deemed severed from this Assignment and the balance of this Assignment shall remain in full force and effect, so long as the original intent of this Assignment remains substantially intact.
