## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 11, 2019 (the “Effective Date”), is made by Wilmington Trust, National Association, in its capacity as collateral agent (the “Collateral Agent”) for the Secured Parties, in favor of Kinetic Concepts, Inc., KCI USA, Inc., Acelity L.P. Inc., Chiron Holdings, Inc., Chiron Topco, Inc., KCI Animal Health, LLC, KCI Holding Company, Inc., KCI HomeCare, Inc., KCI Imports, Inc., KCI International, Inc., KCI Licensing, Inc., KCI Properties Limited, KCI Real Holdings, L.L.C., KCI Real Property Limited, KCI USA Real Holdings, L.L.C. and Technimotion, LLC (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, the Grantors and the Collateral Agent, among others, have entered into that certain Indenture dated as of February 9, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Indenture”) and that certain Intellectual Property Security Agreement dated as of February 9, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreement”);

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, the Grantors executed and delivered that certain Short Form Intellectual Property Security Agreement, dated as of February 9, 2016 (the “IP Security Agreement”), which was recorded with the United States Patent and Trademark Office on February 17, 2016, at Reel 05734, Frame 0044;

WHEREAS, pursuant to that certain IP Security Agreement, each Grantor has granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in and to the Collateral, including the United States registered Trademarks (as defined in the Intellectual Property Security Agreement) and Trademarks for which United States applications are pending, set forth on Schedule I attached hereto (the “Trademark Collateral”);

WHEREAS, Grantor has requested the Collateral Agent to release, discharge, terminate, relinquish and cancel any and all of its Liens on and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Indenture, the Intellectual Property Security Agreement or the IP Security Agreement, as applicable.

2. Release. The Collateral Agent, without recourse, representation or warranty of any kind, hereby releases, discharges, terminates, relinquishes and cancels all of its security interest in and to the Trademark Collateral arising under the Intellectual Property Security Agreement and the IP Security Agreement, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the IP Security Agreement.

4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.



5. Governing Law. This Release shall be governed by the laws of the State of New York, without regard to conflicts of law or choice of law principles.

6. Concerning the Collateral Agent. The Collateral Agent is executing and delivering this Release solely in its capacity as Collateral Agent under the Indenture and the Intellectual Property Security Agreement and not in its individual or corporate capacity. In acting hereunder, the Collateral Agent shall be entitled to all of the rights, privileges, indemnities and immunities afforded to it as Collateral Agent under the Indenture and the Intellectual Property Security Agreement.
