## TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Termination and Release of Intellectual Property Security Agreement (“**Termination and Release**”) is granted as of the 8<sup>th</sup> day of January, 2020 by Wilmington Trust, National Association (the “**Agent**”) in favor of Amerigen Pharmaceuticals, Inc., Amerigen Pharmaceuticals Ltd., Suzhou Amerigen Pharmaceutical Co., Ltd., STP Holding Limited, and STP Holding, L.L.C. Limited (the “**Grantors**”).

WHEREAS, the Grantors executed and delivered an Intellectual Property Security Agreement, dated as of the 30th day of May, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Agreement**”), granting to the Agent a security interest in all of the Grantors’ right, title and interest in, to and under the Grantors’ Intellectual Property Collateral (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on June 4, 2019, at Reel 6660, Frame 0933 with respect to the Trademarks (as defined in the Agreement);

WHEREAS, the Grantors have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Intellectual Property Collateral as herein provided; and

WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Intellectual Property as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:


1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantors’ right, title and interest in, to and under the Intellectual Property Collateral, and all goodwill associated therewith, including, without limitation, those trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS  
OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE  
CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF  
THE STATE OF NEW YORK.
