This Nunc Pro Tunc Trademark Assignment (this "Assignment"), is made and entered into by and between **SONORA MILLS FOODS, INC.**, a Delaware Corporation ("Assignor"), and **VSB OPCO, LLC**, a Delaware limited liability company ("Assignee"), with an effective date of **October 01, 2019**.

Assignor does hereby sell, assign and transfer to Assignee the Assignor's entire right, title and interest in and to the Trademark in the United States together with the Assignor's goodwill in connection with which the Trademark is used, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, together with all income, royalties or payments in respect of the Trademark due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademark, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. The assignment of the Trademark accompanies the transfer of Assignor's business, or portion of the business to which the Trademark pertains, as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060, and that said business is ongoing and existing.

Assignor shall provide Assignee, its successors, assigns or other legal representatives at Assignee's expense, with reasonable cooperation and assistance in the recordation of this Assignment.
