The undersigned hereby certifies and sets forth:

1. The name of the corporation is Salamanca Inc. (hereinafter referred to as the **“Corporation”**).
2. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on June 15, 2016 and was last amended and restated by the Amended and Restated Certificate of Incorporation of the Corporation filed with the Secretary of State of Delaware on July 16, 2018 (together, the **“Certificate of Incorporation”**).
3. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation from Salamanca Inc. to Scroll Labs Inc., so that Article FIRST of the Certificate of Incorporation is hereby amended to read in its entirety, as follows:  
  
**“FIRST:** The name of this corporation is Scroll Labs Inc. (the **“Corporation”**).”
4. This Certificate of Amendment has been duly adopted in accordance with Section 242 of the Delaware General Corporation Law (the **“DGCL”**) by Written Consent of the Board of Directors of the Corporation.
