2. This judgment shall bear interest at the rate prescribed by 28 U.S.C. § 1961 and shall be enforceable as provided by 28 U.S.C. § 2001, et seq., 28 U.S.C. §§ 3001-33017, and Federal Rule of Civil Procedure 69(a).

3. The Court retains jurisdiction over this cause and over the parties for the purposes of entering all further post-judgment orders that are just and proper.
