Pursuant to Section 252 of the General Corporation Law of the State of Delaware (the “DGCL”), the undersigned corporation does hereby certify the following information relating to the merger (the “Merger”) of Synapse Games Incorporated, an Illinois corporation (“Synapse”), with and into Kongregate Inc., a Delaware corporation (the “Company”), with the Company continuing as the surviving corporation:

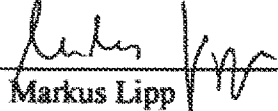
