**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of January 15, 2020, by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as Collateral Agent (the “Collateral Agent”) in favor of **PACTERA TECHNOLOGY INTERNATIONAL LTD.**, a Cayman Islands corporation with an address at Building C-4, No. 66 Xixiaokou Road, Haidian District, Beijing, China 100192 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into an Indenture Trademark Security Agreement dated March 27, 2014 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on April 10, 2014 at the United States Patent and Trademark Office at Reel 5257, Frame 0898.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its trademark collateral, including the Trademarks listed in Schedule A (the “Trademark Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest without recourse, representation or warranty hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
