TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS
(FIRST LIEN)

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 13, 2019 (this "Release"), is made by The Bank of New York Mellon, as successor Administrative Agent for the Secured Parties to Deutsche Bank AG New York Branch (in such capacity and together with its successors and permitted assigns, the "Administrative Agent") in favor of Metalex, LLC (f/k/a Metalex Corporation and successor-by-merger to Morton Manufacturing Company) (the "Grantor").

WHEREAS, the Grantor is party to a First Lien Security Agreement, dated as of June 30, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), between the Grantor and the other grantors party thereto and The Bank of New York Mellon, as successor Administrative Agent to Deutsche Bank AG New York Branch, pursuant to which the Grantor granted a security interest to the Administrative Agent in the Trademark Collateral.

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Administrative Agent, for the benefit of the Secured Parties, (i) the Trademark Security Agreement dated as of June 30, 2014 (the "2014 IP Security Agreement") and (ii) the Trademark Security Agreement dated as of March 21, 2019 (the "2019 IP Security Agreement"; together with the 2014 IP Security Agreement, the "IP Security Agreements" and each an "IP Security Agreement"); and

WHEREAS, (i) the 2014 IP Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on June 30, 2014 at Reel 5312 Frame 0460, Reel 5312 Frame 0506 and Reel 5312 Frame 0644 and (ii) the 2019 IP Security Agreement was recorded at the USPTO on May 2, 2019 at Reel 6635 Frame 0988.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Administrative Agent, on behalf of the Secured Parties, and the Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized definitional terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreements, as applicable.

SECTION 2. Termination and Release. The Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, re-pledges, reassigns and releases to the Grantor the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under:

(i) all Trademarks of the Grantor, including those listed on Schedule A attached hereto;

(ii) all the right to sue or otherwise recover for past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to goodwill, and all Proceeds of the foregoing, including license fees, royalties, income, payments, claims, damages and proceeds of suit;

- (iii) all other rights accruing thereunder or pertaining thereto throughout the world; and
- (b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

SECTION 4. Acknowledgement. The release of security interest granted herein expressly does not include a release of the security interest granted in any Trademark Collateral not listed on Schedule A.
