## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release"), dated as of November 22, 2019 (the "Release Date"), is made by SunTrust Bank ("SunTrust") for the benefit of **ELEMENTS INTERNATIONAL GROUP, LLC**, a Texas limited liability company ("EIG"), **AVALON REAL ESTATE HOLDINGS, LLC**, a Delaware limited liability company ("Avalon"), **KYVNO, LLC**, a Delaware limited liability company ("Kyvno") **AND ELEMENTS INTERNATIONAL GROUP (CANADA), INC.**, a British Columbia corporation ("EIGC") (hereinafter EIG, Avalon, Kyvno and EIGC may be collectively referred to as "Debtors" or individually referred to as a "Debtor").

**WHEREAS**, Debtors and SunTrust are parties to a Loan Agreement (as amended, supplemented, restated or otherwise modified from time to time, the "Loan Agreement"), dated as of December 21, 2018, pursuant to which Debtors irrevocably granted, assigned and pledged to SunTrust a continuing security interest (the "Security Interest") in the Debtors' Trademarks and all products and proceeds thereof (collectively, the "Trademark Collateral"), to secure the Obligations;

**WHEREAS**, SunTrust has filed with the United States Patent and Trademark Office (the "USPTO") a Trademark Security Agreement, dated as of December 21, 2018 (the "Security Agreement");

**WHEREAS**, the Security Agreement was recorded by the USPTO on December 28, 2018, at Reel 6511, Frame 0064; and

**WHEREAS**, Debtors have requested that SunTrust enter into this Release in order to effectuate, evidence and record the release and reassignment to Debtors of any and all right, title and interest SunTrust may have in the Trademark Collateral pursuant to the Security Agreement.

**NOW THEREFORE**, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, SunTrust agrees as follows:

1. Definitions. All capitalized terms that are used but not otherwise defined herein shall have the meanings given to them in the Loan Agreement or Security Agreement.

2. Release of Security Interest. Effective as of the Release Date, the Lender hereby irrevocably and forever terminates, releases and discharges the Security Agreement, any and all of its security interest in, and all of its right, title and interest in, to and under, the Trademark Collateral granted by the Debtors under the Security Agreement and Loan Agreement.

3. Recordation of Release. SunTrust understands and agrees that this Release may be recorded by or for the Debtors with the USPTO.

4. Further Actions. SunTrust further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that Debtors may reasonably require to effect the intent and purpose of this Release.

IN WITNESS WHEREOF, SunTrust has caused this Release to be executed as an instrument under seal by its duly authorized officer as of the Release Date.
