APPENDIX B

CONFIRMATORY U.S. TRADEMARK ASSIGNMENT

THIS CONFIRMATORY U.S. TRADEMARK ASSIGNMENT is entered into as of December 13, 2019 (this "Confirmatory Assignment") by and between and Moen Incorporated, a Delaware corporation (together with its successors and permitted assigns, "Moen") and FB Global Plumbing Group LLC, a Delaware company, (together with its successors and permitted assigns, "GPG").

RECITALS:

WHEREAS, Moen owns certain trademark applications and registrations in the United States as specifically described on Schedule A (which may be amended from time to time) along with any issuances, extensions, and renewals thereof (the "Trademarks").

WHEREAS, Moen desires to transfer and assign to GPG, and GPG desires to acquire from Moen, Moen's entire right, title and interest in the Trademarks together with the goodwill symbolized by such Trademarks in the United States; provided that no rights in any United States intent-to-use trademark applications shall be assigned to GPG by this Confirmatory Assignment.

NOW, THEREFORE, in consideration of the mutual agreements between the parties signed contemporaneously herewith, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Trademark Assignment. This is to confirm for recordation purposes that Moen has contributed, assigned, conveyed, granted and transferred to GPG, and GPG accepts, the following:

(a) Moen's entire right, title and interest in and to the Trademarks in the United States and its territorial possessions, whether or not such Trademarks have been registered prior to, on or after the date of this Confirmatory Assignment, and any and all renewals and extensions (or any legal equivalent) thereof for the full term or terms for which the same may be granted, together with all goodwill associated with such Trademarks in the United States;

(b) any and all claims, demands and rights of action whatsoever with respect to any of the foregoing, whether accruing before, on, or after the date hereof, both statutory and based upon common law, that Moen has or might have by reason of any infringement or any related claims together with the right to prosecute such claims, demands and rights of action in GPG's own name, including but not limited to (i) infringement, misuse, violation, breach, default, dilution or unfair competition relating to any of the foregoing, (ii) all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief based the foregoing conduct whether past, present, or future, and (iii) the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages,

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) all rights corresponding to the foregoing in the United States and its territorial possessions, as fully and entirely as the same would have been held and enjoyed by Moen had this Assignment not been made, including without limitation rights arising under any applicable law in the U.S. or by international treaties and conventions.

2. Further Assurance. Moen agrees that it shall do, execute, acknowledge and deliver all acts, agreements, instruments, notices and assurances as may be reasonably requested by GPG to further effect and evidence the transactions contemplated hereby, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Trademarks to GPG, or any assignee or successor thereto. Moen hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Assignment upon request by GPG.

3. Enforceability. If any provision of this Confirmatory Assignment shall be invalid or unenforceable, in whole or in part, or as applied to any circumstance, under the laws of any jurisdiction which may govern for such purpose, then such provision shall be deemed to be modified or restricted to the extent and in the manner necessary to render the same valid and enforceable, either generally or as applied to such circumstance, or shall be deemed excised from this Confirmatory Assignment, as the case may require, and this Confirmatory Assignment shall be construed and enforced to the maximum extent permitted by law as if such provision had been originally incorporated herein as so modified or restricted, or as if such provision had not been originally incorporated herein, as the case may be.

4. Amendment. This Confirmatory Assignment may not be amended or supplemented orally, but only by an instrument in writing signed by both Moen and GPG.

5. GOVERNING LAW. EXCEPT TO THE EXTENT OTHERWISE EXPRESSLY PROVIDED HEREIN, THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE SUBSTANTIVE LAWS OF THE STATE OF DELAWARE, WITHOUT GIVING EFFECT TO THE PRINCIPLES OF CONFLICT OF LAWS THEREOF.

6. Counterparts. This Confirmatory Assignment may be executed in counterparts, each of which shall be deemed an original, but which together shall constitute one and the same agreement.

7. Successors and Assigns. This Confirmatory Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.

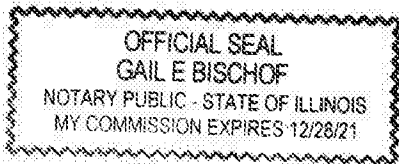

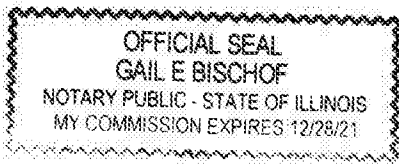
