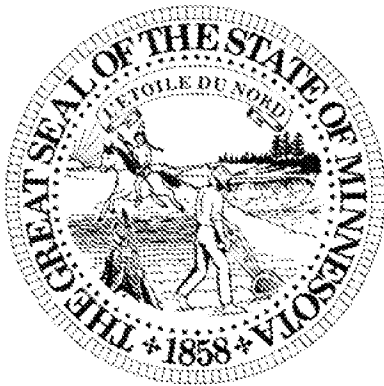

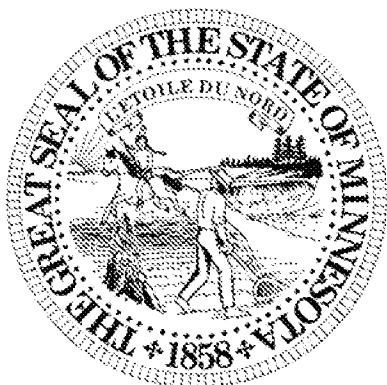

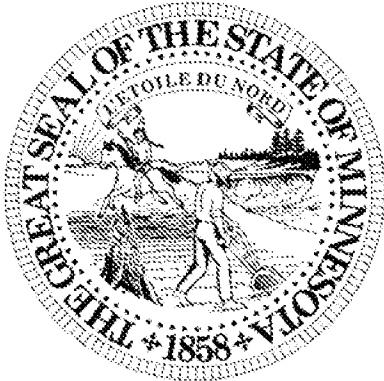

A Plan of Conversion was adopted by LJK Companies, Inc., a Minnesota corporation (“LJK Companies, Inc.”).

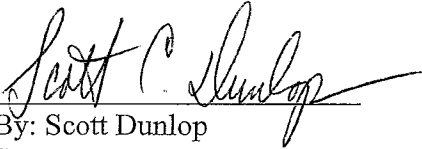

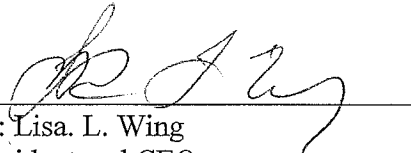

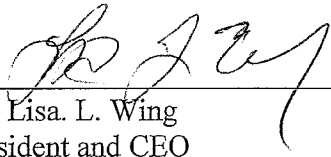
