**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of November 21, 2019 (the "Trademark Security Release"), is made by MARANON CAPITAL, L.P., a Delaware limited partnership, in its capacity as agent (in such capacity, the "Agent") under that (i) certain Trademark Security Agreement, dated as of September 30, 2014 (as amended, supplemented or modified and in effect from time to time, the "2014 Trademark Security Agreement") by and among MILTON INDUSTRIES, INC., a Delaware corporation (the "Grantor") and the Agent and (ii) certain Trademark Security Agreement, dated as of November 20, 2017 (as amended, supplemented or modified and in effect from time to time, the "2017 Trademark Security Agreement") by and among the Grantor and the Agent (together with the 2014 Trademark Security Agreement, collectively the, "Trademark Security Agreement"). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to (i) the 2014 Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on September 30, 2014 at reel 5371, frame 0089 and (ii) the 2017 Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on November 21, 2017 at reel 6214, frame 0332, the Grantor granted to the Agent, for the benefit of the Lenders a security interest in all of Grantor's right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule I;

WHEREAS, the Obligations secured by the Trademark Collateral have been repaid; and


WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Agent in the Released Collateral.
