**RELEASE OF SECURITY
INTEREST IN TRADEMARKS**

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Releasor hereby, without any representation and warrant and without any recourse to Releasor, releases, relinquishes and discharges its security interest in and any and all liens upon the Intellectual Property Rights and Trademarks, and assigns and transfers to Releasees all of Releasor's rights in and to the Intellectual Property Rights and Trademarks.
